## UTMOST IMPORTANCE BELOW\*\*\*

**\*\*\*REGION REGISTRATION:** All players must register with our Region to play in any USAV event, and also to practice. Instructions are on our Register with the Region and Medical release page on our website. .

**\*\*\*MEDICAL RELEASE:** We must have a USAV medical release on each player before they can practice. Please include the medical release for your player with your Nov. 1st payment. Find this form on our Register with the Region and Medical Release page.

### **HOTEL INFORMATION:**

I have blocked rooms for both our New Orleans trip in January, and the Dallas event in April. The HOTELS page on our website has all the information, as well as instructions on how to book a room in our block. **YOU DO NOT GO THRU THE HOTEL TO DO THAT.** Follow instructions on our hotels page.
